In Some institutions, respiratory intensive care unit is with department of Anaesthesia, in others with medicine Department and in still others with respiratory medicine department. The Dean has stated in his remarks that 5 beds are earmarked for respiratory critical care in 15 bedded MICU. As only 5 beds are required in MICU, it is well within discretion of the institute to demarcate 5 beds for respiratory critical care which can be a substitute to RICU. Hence not considered as deficiency. Moreover the letter of permission was given in 2012 by the Board of governors appointed by the Central Government with same arrangement. Hence there is no justification for denying recognition of the course started with proper LOP from board of Governors and same arrangement of RICU as existing now.
2.	Renewal for Blood Bank license is applied examinations are conducted as per MCI norms.	It is a common practice that Licensing authorities take long time in renewing the Blood Bank license and it is acceptable that if the college authorities have applied for renewal in time, they can continue to run the blood bank till renewal and this arrangement is acceptable by MCI. It is convention that as per directions of FDCA, application for renewal is to be treated as permissible if it is not specifically prohibited by FDCA from functioning as Blood Bank if original license was issued by FDCA. That being the case, this was not considered as deficiency.

These recommendations have been approved by Oversight Committee vide letter dated 16.11.2017.
